**2. Fooyya'iinsa**

Labsii Akkaataa Gurmaa'ina, Hojimaata, Naamusa Miseensotaa fi Sirna Walgahii Caffee Mootummaa Naannoo Oromiyaa Irradeebiidhaan Fooyyessuuf Bahe, **Lakk. 153/2001** akkaataa kanatti aanee jiruun fooyya'era.

1) Gurmaa'ina Caffee waliigalaa Keewwaata 3 Keewwata Xiqqaa 1 (b) jalatti maqaan "Waajjira Afyaa'ii fi Caffee" jedhu "Waajjira Caffee" jedhamuun kan fooyya'e yoo ta'u, maqaan waajjirichaa seerota biroo keessatti duraan tuqamee tures haaluma kanaan kan fooyya'ee dubbifamu ta'a.

2) Keewwata 3 Keewwata Xiqqaa 3 tti aanee keewwatni Xiqqaan 4 haaraan dabalameera. "Caffeen asxaa addaa (Logo) maalummaa isaa agarsiisu ni qabaata." Tarreeffamni isaa Dambiidhaan kan murtaa'u ta'a.

**2. Amendment**

The Revised Proclamation to define the Organization, Duties, Ethics of the Members and Meeting Procedures of 'Caffee', Proclamation No. 153/2009 is revised as follows;

1) The name mentioned as "Office of the Speaker and Secretariat of 'Caffee'" under article 3 sub article 1(b) shall be amended as "Secretariat of 'Caffee'", the previous name of the secretariat in other laws shall be read as conform to this amendment.

2) New Sub Article 4 is added to article 3 that read as, "The 'Caffee' shall have logo that express its distinctiveness". The details shall be enacted by Regulations.

**3. Effective Date**

This Proclamation shall come into force as of the date of its publication on 'Megeleta Oromia'.
