Whereas, when the electors lose confidence in the members of the Wereda and Kebele Councils, may recall them from their posts, and the conditions in which the elections be conducted to replace the removed members must be clearly governed by the law;

Now, therefore, in accordance with Article 98 of the Constitution of the Oromia Regional State, it is hereby proclaimed as follows:

#### 1. Short Title

This Proclamation may be cited as the "Oromia Regional State Constitution (Amendment) Proclamation No. 21/1997."

#### 2. Amendments

The Oromia Regional State Constitution is hereby amended as follows:

1. Article 78(3) is hereby deleted and replaced by the following new sub-article.

(3):

"3. The term of office of the Wereda Council shall be five years. Prior to the end of the term of office of the outgoing council members, new election shall be conducted and completed."

2. The following new sub-article (4) is added under Article 78:

"4. When the electors lose confidence in any one of the council members, the member shall be removed from the membership of the council in accordance with the law."

3. Article 86(3) is hereby deleted and replaced by the following:
