**PROCLAMATION No. 22/1997**  
A PROCLAMATION ON LOSS  
OF REPRESENTATION OF THE  
COUNCIL MEMBERS

Whereas, the councils at all levels in the Region are established in accordance with the Constitution of the Oromia Regional State;

Whereas, the Proclamation No. 5/1995 which defines the rights and duties of the members of the council has been issued based on the Constitution;

Whereas, the electors may recall or remove a council member in accordance with Article 12(2) of the Constitution, whenever they lose confidence on him;

Now, therefore, in accordance with Article 49(3)(a) of the Constitution of the Oromia Regional State, it is hereby proclaimed as follows:

### **1. Short Title**

This Proclamation may be cited as the "Loss of Representation of Members of the Council Proclamation No. 22/1997."

## 2. Definitions

In this Proclamation, unless the context otherwise requires:

- a) "Council" means the Oromia Council, wereda Council or Kebele Assembly established in accordance with the Constitution of the Oromia Regional State Article 46(1) or 74(1) or 84(1) respectively.
  - b) "Executive Committee" means the Executive Committee of the Regional State, Zone or Wereda or Kebele established in accordance with Articles 53(1), 77(h) and 85(3) of the Constitution of the Oromia Regional State respectively.
  - c) "Member" means a member of the council elected in accordance with Article 48(1) or 76 or 84(2) of the Constitution of the Oromia Regional State.

### **Basic Rights**

  1. Any resident of the Region has the right to elect members of councils established at all levels.
  2. Any resident of the Region may, together with other electors, examine, evaluate, and weigh the member periodically.
  3. Any resident of the Region has the right to withdraw or stop or maintain support for his member.

(b) Dambii Boordiin, Filatnoo baasu irraatti hunda'uudhaan Naannoo Filatnoo, miseensi Caffee Naannoo bakka bu'aa bakka itti ta'etti yaadachiisa filattoota kuma kudhaniin dhiyaate deggaruudhaan Caffeen Aanaa sagalee caalmaan bakka bu'ichi debi'ee akka waamamu kan murteesse yoo ta'e;

(c) Dambii Boordiin Filatnoo baasu irratti hunda'uudhaan Naannoo filatnoo miseensi Caffee Aanaa yookiin yaa'ii Gandaa bakka bu'aa bakka itti ta'etti filattoota argaman keessa 750 ol kan ta'anu miseensummaa irraa akka ka'u gaaffii Boordii Flatnootiif yemmuu dhiyeessan;

(d) Haala naamusa isaa irraa ka'uudhaan Caffeen inni miseensa itti ta'e sgalee 2/3n miseenschi uummataa isafilate bakka bu'uuf ga'eesummaa hin qabu jedhee enna murteesse ta'a.

4. Any member has the right to convey clearly his opinion, oppose or accept the criticism, or express thanks, gratitudo and evaluation addressed to him by the electors.

#### 4. Method of Evaluating the Confidence of the Electors

A member shall be deemed to have no confidence of the electors where:

a) in accordance with Regulations to be issued by the Electoral Board, more than 15,000 electors of constituency forward demand to the Electoral Board that he step down

b) upon initiation by 10,000 electors of his constituency and in accordance with Regulations to be issued by the Electoral Board, the Wereda Council passes decision by a majority vote to the effect that he shall be recalled;

c) upon initiation by 750 electors of his constituency and in accordance with Regulations to be issued by the Electoral Board, demand that a member of the Wereda council Kebele assembly be stood down;

d) the council to which he is a member decides by a two-thirds vote that he has failed to competently represent his electors in view of the misconduct he has manifested.

#### 5. Standards of good conduct

Any member:

- (c) Ragaa sobaa uumuu; sobuu, dhimmoota hin qulqullaayin sobaan waltajjii mariitti dhiyeessuun haallan muummeyyii namuusa dhabiiinsi ittiin ibsamuu dha.

1. Dhimmi miseensa namuusa dhabee jedhamee tokko koree Caffeen inni miseensa itti ta'e dhaabuun calalma.

- a) has to be of a clean standing in every respect, in consequence of having to be governed by his conscience as well, pursuant to Article 48(3) of the Constitution;
- b) shall have the responsibility to be honest and open in deliberations of public affairs;
- c) shall not create false evidences, lie and forward unsubstantiated matters to the flock which shall be taken as major manifestations of misconduct.

#### 6. Measures to be taken against misconduct

1. The case of a member alleged for a misconduct behaviour shall be investigated by a committee established by the concerned council.

2. The council shall deliberate upon the recommendation of the committee of inquiry and pass its decision on the case.

3. The council may, when it deems necessary, take the following measures against the member who is found to be of misconduct behaviour:

- to issue him a warning or reprimand which shall be made known to the public;
- to suspend him from membership of the Council for a definite time;

c) if the member continues with the misconduct behaviour after the measures specified under (a) and (b) above are taken against him, the Council may cancel him from the membership by 2/3rd vote.

4. The disciplinary measures listed under sub-article 3(a-c) of this Article may be applied in disregard thereof, where the gravity of the fault so justifies.

7. Consequences of Dismissal
1. When a member is removed/recalled in accordance with Articles 4 and 5 his Identity Card becomes invalid.
  2. Without prejudice to the provisions of sub-article (1) of this Article, the former member whose representation is cancelled may participate in the election that shall be conducted to replace him.
  3. The election time governed under sub-article (2) of this Article shall take place at the time when the Executive Committee of the Regional State decides after consultation with the Electoral Board.
  4. The time governed under sub-article (3) of this Article shall not exceed beyond three months.
8. Repeal  
From the provisions of Proclamation No. 5 (Definition of Rights and Duties of Council members), the following articles are hereby repealed:
- a) Article 9,
  - b) Article 11 (a) and (b),
  - c) Article 12 (sub-article(1)),
  - d) Article 13.
9. Effective Date  
This Proclamation shall be effective beginning November 9, 1997.
