A PROCLAMATION TO AMEND THE CONSTITUTION OF THE REGIONAL STATE OF OROMIA

Whereas, Finfine is currently serving as a Capital City for both the Federal democratic Republic of Ethiopia and Regional State of Oromia as well as it has its own administration;

Whereas, it is found necessary to establish our own separate Captial City;

Now, therefore

- Short Title**
 This Proclamation may be cited as the “Constitution of the Regional State of Oromia (Amendment) Proclamation No.34/2000.”
- Repeal**
 Article 6 of the Constitution of the Regional State of Oromia is hereby repealed and replaced by the following new Article 6:
 “Adama shall be the Capital City of the Regional State of Oromia.”
